### Notification for 2<sup>nd</sup> phase of Social Audit in 3 Blocks Under Paschim Bardhaman District

As per schedule, we are going to conduct 2<sup>nd</sup> phase social audit for MGNREGS, PMAY & NSAP schemes in 3 Blocks viz. Kanksa, Baraboni and Salanpur under Paschim Bardhaman District, which was prescribed by MoRD, Govt of India.

In this 2<sup>nd</sup> phase, MGNREGS, PMAY and NSAP schemes would be social Audited in 26 nos. of Gram Panchayet under 3 Blocks for the following period,

1. MGNREGS :- F.Y.2017-18 ( from 01.04.2017 to 31.10.2017)
2. PMAY :- F.Y.2017-18 ( from 01.04.2017 to 31.10.2017)
3. NSAP :- F.Y.2017-18 ( from 01.04.2017 to 31.10.2017)

Hence, 260 Nos . of Village resource persons (VRP) will have to be engaged to facilitate the Audit process in this phase from 3 Nos. of Development Block. The detailed information cum Advertisement along with VRP engagement application format is attached herewith. In this regard, the candidates who have been selected to work as VRP in 2015-16 for Kanksa & Salanpur Block, are instructed to submit an application (as a group of 10 VRP per GP where they have worked earlier) with a request for working as VRP in this phase to the office of the Block Dev. Officer in their concerned block office within 10/01/2018. Anyone found absent in that list will not be able to continue their service further. In case of Baraboni Block, 80 Nos. of VRP will be selected freshly in this phase.


