ORDER

Out of total fund of Rs. 1,79,50,800 lakh (Rupees one crore seventy nine lakh fifty thousand eight hundred) only received from the OSD & Ex-Officio Dy. Secretary to the Govt. of West Bengal, Panchayat & RD Deptt. Vide No. 124(Sanction)-PN/N/II/3F-11/00 dated 07-11-2005 as grant against collection of Entertainment Tax and Luxury Tax for supplementing the own fund to three tiers of Panchayat Bodies, an amount of Rs. 1,25,65,600/- (Rupees One crore twenty five lakh sixty five thousand six hundred) only is hereby sub-allotted to the Panchayat Samities and Gram Panchayats in this district as per the statement enclosed in Annexure-A.

The Block Development Officers shall draw the fund in grant-in-aid bill and disburse the same to the Panchayat Samiti and the Gram Panchayat as per their entitlement. Grant of the Panchayat Samiti shall be kept in the LF Account for subsequent utilization by the Panchayat Samiti. Gram Panchayats will get its share as per entitlement prescribed by the Ist SFC. The BDOs They shall report the TV No. and date under which the fund is drawn to the District Magistrate for onward submission.

The charge in this respect are debitible to the head of account "3604 compensation and Assignments to Local Bodies and Panchayati Raj Institutions -00-103-Entertainment Tax-NP-NON-PLAN-001-Grants-in-aid to the Panchayat from Panchayat Fund [PN]-V-31-Grants-in-aid-02-Other grants" during the financial year 2005-06.

It should be borne in mind that allotment of fund is no authority to incur any expenditure unless such expenditure is cover by sanction of the appropriate rules / authority. Under no circumstances should any expenditure be incurred in excess of the allotment.

The grants as sanctioned should be treated as Untied (NP) own fund of the PR Body and should be used to finance the maintenance of civic services in rural areas. These includes provision for maintenance of facilities for primary education, primary health care, drinking water supply etc. owned by the Panchayats, street light, sanitation including drainage and scavenging facilities, maintenance of cremation and burial grounds, public conveniences and other common property resources. The schemes should normally be those that are not/cannot be covered under other programmes of GOI or Govt. of West Bengal. The Panchayet Samities and Gram Panchayets should utilize the funds allotted within 28th February-2005
